If the application is approved, a lease commencement date must be arranged and an appointment made with the property manager for signing the lease documents and pick up of keys.

The holding deposit of one weeks rent must be paid into an EFT transaction into Skyrise rental trust account.

The initial payment of bond must be paid through rental bonds online in which you will receive an email and must be paid prior to the lease commencement date.
